<i>The candidate must show evidence of the ability to complete tasks outlined in elements and performance criteria of this unit, manage tasks and manage contingencies in the context of the job role.</i>	
There must be demonstrated evidence that the candidate has completed the following tasks at least once in line with state/territory regulations, first aid codes of practice, ARC guidelines and workplace procedures:	
- <i>conducted a hazard assessment and identified strategies to minimise risk</i>	
- <i>demonstrated safe manual handling techniques</i>	
- <i>assessed airway, breathing and responsiveness of casualty</i>	
- <i>performed at least four minutes of uninterrupted CPR on both an adult and an infant resuscitation manikin placed on the floor, demonstrating the following techniques on each:</i>	
- <i>checking for response and normal breathing</i>	
- <i>recognising abnormal breathing</i>	
- <i>opening and clearing the airway</i>	
- <i>using correct hand location, compression depth rate in line with the ARC recommended ratio of compressions and ventilations</i>	
- <i>acting in the event of regurgitation or vomiting</i>	
- <i>following single rescuer procedure, including the demonstration of a rotation of operators with minimal interruptions to compressions</i>	
- <i>followed the prompts of an Automated External Defibrillator (AED)</i>	
- <i>provided an accurate verbal report of the incident</i>	
- <i>responded to at least one simulated resuscitation scenario contextualised to the candidate's workplace/community setting.</i>

- legal, workplace and community considerations, including:	
- <i>need for stress-management techniques and available support following an emergency situation</i>	
- <i>duty of care requirements</i>	
- <i>respectful behaviour towards a casualty</i>	
- <i>own skills and limitations</i>	
- <i>consent</i>	
- <i>privacy and confidentiality requirements</i>	
- <i>importance of debriefing</i>	
- considerations when providing CPR, including:	
- <i>airway obstruction due to body position</i>	
- <i>appropriate duration and cessation of CPR</i>

- <i>absence of normal breathing</i>

ASSESSMENT CONDITIONS

Assessment Conditions	Task / Question Map
Skills must be demonstrated working individually:	
- <i>in an environment that provides realistic in-depth, industry-validated scenarios and simulations to assess candidates' skills and knowledge.</i>	
In addition, assessment resources must include:	
- <i>adult and infant resuscitation manikins in line with ARC Guidelines for the purpose of assessment of CPR procedures</i>	
- <i>equipment, including:</i>	
- <i>an Automated External Defibrillator (AED) training device.</i>	
<i>Simulated assessment environments must simulate the real-life working environment where these skills and knowledge would be performed, with all the relevant equipment and resources of that working environment.</i>	
Assessors must satisfy the NVR/AQTF mandatory competency requirements for assessors. In addition, assessors must hold:	
- <i>a current advanced first aid certificate</i>	
OR	
- <i>at least three years' experience as a health professional, nurse or emergency services provider</i>
